Dear neighbours,

As this newsletter lands on your doorstep, the leaves are beginning to change and fall is in the air. It's one of my favourite times in Don Valley North and reminds me of just how lucky we are to live in such a beautiful part of the city.

A year ago, I was writing to you to share that I'd just been appointed Budget Chief. When I accepted this role, I knew it meant working tirelessly to ensure your hardearned property tax dollars are being spent effectively and for maximum impact. I worked with staff to find over \$600 million in savings in advance of the 2024 Budget the most ever found in a single year.

I also engaged with thousands of neighbours and Torontonians through in-person Budget consultations, Telephone Town Halls, and more. What I heard in every setting was that you want things to get better here in Toronto. You want to be able to rely on our roads and our transit system, to afford living here, and to feel safe in your community. You want to see garbage bins emptied and our parks kept in good condition. You want Toronto to get back on track.

I know that my Council colleagues and I asked you to make a significant investment in our city this year. I'm proud to report that those investments are paying off.

We're hiring hundreds more police officers, firefighters, and paramedics to reduce emergency response times and keep you safe. We've increased safety on our transit system with more staff present across the system. We've also made key investments in areas like long-term care and public libraries to support the overall well-being of Torontonians.

As we approach the 2025 Budget, I am reviewing every department's budget carefully to identify more opportunities for savings wherever possible. And just like last year, I want to hear from you. There are details on how to get involved on the back page of this newsletter.

Parks & Environment

Dogs Off-Leash Areas

We have two dogs off-leash areas (OLAs) in the works here in Don Valley North. Staff are finally set to proceed with the construction of the new OLA in Parkway Forest Park. I want to thank the community members who engaged in the consultations for this project back in 2020 and 2021. This dog park will be located south of the school parking lot and will include additional park upgrades like a new pathway, benches, a water bottle filling station, and more. City staff will soon be consulting the community for a proposed OLA at Old Sheppard Park. This project was voted on by the neighbourhood in a past Participatory Budgeting process, and I am glad we're moving forward to gather more community feedback. You'll be able to find the consultation details at toronto.ca/OldSheppardOLA in the coming weeks.



A portion of the Betty Sutherland Trail is closed due to work along Highway 401 being completed by the Provincial Ministry of Transportation. The closure is scheduled to be in place until 2026 and has made journeys significantly more dangerous for hundreds of pedestrians and cyclists. I moved a motion at City Council last year requesting that the Province explore solutions to provide a safe alternative for trail users. Unfortunately, City Council has not seen any substantial progress from the Province on this issue over the past year. Rest assured I will keep advocating for a safer alternative for our community.

East Don Ravine

Work is progressing nicely in the East Don Ravine. The primary goal of this work is to increase local sewer capacity to serve our growing community along Sheppard Avenue. The City has also bundled in essential erosion control work to protect the riverbed and make this project as efficient as possible. A small portion of the trail is closed until December 2025. Transportation



Bike Share Toronto is now available in Don Valley North! Bike Share is steadily expanding into the inner suburbs, providing more options for active transportation. We now have seven brand-new stations along Sheppard Avenue and up Don Mills Road towards Finch Avenue. These are our firstever stations, and I look forward to this program expanding in the years to come. Visit bikesharetoronto.com to see a map of locations and learn more about this great program.

Sheppard Line Extension

The Provincial government has completed multiple community consultations on the Sheppard Line Extension. I joined both consultations here in Don Valley North and heard our community call for a subway. I have been advocating to expedite this much-needed subway since the Province first announced the project back in 2019. I hope to see the Province commit to and deliver this project for our growing communities in North York and Scarborough. You can learn more at metrolinx.com/sheppard.

Permanent Speed Camera

The City has 75 Automated Speed Enforcement (ASE) cameras located in Community Safety Zones across Toronto. These cameras have proved to be highly effective in reducing speeding, which is especially important around our schools. So far, the program has rotated the location of these cameras every three to six months. We now have a permanent ASE camera coming to the north side of Sheppard Avenue East, west of Don Mills Road. Be sure to watch your speed heading westbound as you move through the intersection and start down the hill towards St. Timothy Catholic School.
